**Declaration**

- No lame, blind, injured, sick or substituted animals will be loaded on road transport to the loading facility.
- During transport to the authorised assembly depot no animals other than those described above were loaded.
- The livestock were born and raised in Australia.
- To the best of my knowledge, livestock sourced for export comply with Australian Food Safety requirements including standards for chemical residues or environmental contaminants.
- The animals are free from clinical evidence of any disease during the past 30 days in particular, ringworm, pinkeye, lumpy jaw and dermatophilosis.
- The livestock and the property for export have been free of any known outbreaks or clinical symptoms for at least six (6) months prior to shipment for the following diseases; Tetanus, Malignant Oedema, Blackleg, Pulpy Kidney, Black Disease, Bovine Cysticercosis, Intestinal Salmonella (Salmonellosis), Theileriasis, Hendra Virus
- The livestock and the property for export have been free of any known outbreaks or clinical symptoms for at least twelve (12) months prior to shipment for the following diseases; Infectious Pustular Vulvo-vaginitis (IPV), Anaplasmosis, Babesiosis, Botulism, Actinomycosis (Lumpy Jaw), Sporadic Bovine Encephalomyelitis, Trichophytosis (Ringworm), Contagious Ophthalmia (pinkeye), Dermatophilosis, Surra,
- The livestock and the property for export have been free of any known outbreaks or clinical symptoms for at least twenty-four (24) months prior to shipment for the following diseases: Bovine Genital Campylobacteriosis (Vibriosis) and Trichomoniasis
- All livestock and the property of origin showed no clinical signs or abattoir evidence of Enzootic Bovine Leucosis (EBL), Bluetongue, Mucosal Disease/Bovine Virus Diarrhoea (MD/BVD), Infectious Bovine Rhinotracheitis (IBR), 'Q' Fever, Haemorrhagic Septicaemia, Ephemeral fever, Bovine Malignant Catarrhal fever and Leptospirosis during the previous three (3) years.
- The animals and property have had no officially reported cases of Johne's Disease (Paratuberculosis) in the previous five (5) years.
- I further declare that the animals have never been fed with any kind of processed animal products excluding milk protein.
- The animals for export originate from an area free from Anthrax for at least the previous 12 months prior to export.
- The animals for export originate from properties which are officially free from Tuberculosis and Bovine Brucellosis, clinical Bluetongue
- The animals for export have been vaccinated against Botulism (buffalo to Indonesia only)
- I give permission for the relevant State Department to disclose animal health information relating to my property to a third party, for the purpose of the export of live animals that have resided on my property.
- The livestock to be exported are NLIS identified and registered on the NLIS database against this Property Identification Code (PIC) where they currently reside.
- No livestock are within a withholding period or Export Slaughter Interval for antibiotics. The livestock do not contain hormone growth promotant (HGP) residues at levels harmful to human health, as determined by Codex Alimentarius food safety standards.

**Note : Commonwealth legislation provides that giving false or misleading information is an offence, with penalties up to five years imprisonment.**

I, \_\_\_\_\_ (BLOCK LETTERS), being the authorised management representative of the above-mentioned property, declare to the best of my knowledge, the animals prepared and handled for export have met the following-

- Animals comply with all relevant state/territory health & welfare legislation under the national Model Codes of Practice for the Welfare of Animals, ASEL 3.0 Land Transport Standards, OIE (World Organization for Animal Health) Chapter 7.3 (Transport of Animals by Land) and national model codes of practice regarding on-property management and land transport. (ASEL 3.0-S1.1, S2.1)
- No chemical residues or environment contaminants are known to be present in livestock. (ASEL 3.0-S1.1.4)
- Livestock must be fit to travel as per livestock order specifications. Livestock must be inspected before loaded and not have any condition that could cause the animals' health to decline during transport or export preparation. If you are unaware of the rejection criteria, please notify the exporter for a copy to be supplied. (ASEL 3.0-S1.1.6, Table 1) The owners and managers of the livestock are responsible for the general health, overall welfare and fitness of the animals for the journey (OIE A.7.33)
- Livestock have been mustered and handled to prepare for land transportation to maintain health and fitness for travel. Including:
  - Travel > 24hrs, then feed/water/rest for 12 hrs before curfew at a location close to loading point.
  - If helicopter mustered, then feed/water/rest for 24hrs before curfew.
- **Holding areas and loading facilities** to be secure, safe, and well constructed.
- **Vehicle** used for transport of livestock to registered premise must meet the following criteria:
  - Be registered for that purpose under a law of a state/territory.
  - Be suitable for the species, class, condition and number of livestock and minimise injury.
  - Enable livestock to freely stand without contact of overhead structures.
  - Be suitably ventilated for the climate with no exhaust fume pollution.
  - Have drainage on upper decks that does not soil livestock on lower decks.
  - Be serviced / maintained in good mechanical/structural condition, including stock crate.
  - Be clean before the journey.
  - Transport operators are responsible for this requirement and must maintain a journey log book.
- **Feed and water curfews** as per below:
  - Livestock off water and green feed for 12hrs, dry feed no curfew.
  - Livestock off green feed for 12hrs, dry feed & water no curfew.
- Livestock are **drafted and loaded** according to species, class, age, weight, size, horns and possibility of showing aggression & or causing injury. Livestock with horns over 12cm separated from other livestock.
- Livestock were loaded in a manner that prevents injury and minimises stress including loading densities and penning arrangements. The person responsible for the land transport vehicle must be responsible for the livestock.
- Working dogs are not transported in the same pens as livestock
- Only experienced livestock handlers are to prepare and load livestock to prevent injury & stress. Any sick or injured animals must be promptly & humanely handled.
  - Minimal **electric prod** use, not to be applied to face/genitals.
  - Where animals need to be lifted to assist in loading, must **not be lifted by the skin**.
  - Rattles may be used for sound to encourage movement, **polypipe** must be used humanely.
  - **Well trained dogs** may be used to assist in handling.
- Livestock will be unloaded and rested as specified in Land Transport Standards and in accordance with state/territory legislation. At unloading the livestock will become the responsibility of the management personal of the registered premises. Distressed or injured livestock must be given immediate assistance. Humane euthanasia to be carried out if necessary.
- Livestock will be unloaded into registered premises by competent stock handlers in a manner that prevents injury and minimises stress (ASEL 3.0- 3.1.13)
- Livestock must be weaned at least 14 days before transport. (ASEL 3.0-S1.4.1, S1.2.1, S1.7.1)
- Females determined not to be pregnant. (ASEL 3.0-S1.2.5, S1.4.5, S1.7.6) (Applicable form must be completed and attached.)

The original is to be attached to Waybills and handed to transport driver for carriage to registered depot. It is a requirement of the Australian Livestock Export Standards (Version 3.0) "when receiving and identifying livestock, the Depot Operator must obtain a copy of the Vendor Declaration/s regarding the property of source and health status of the livestock before accepting the livestock for the purpose of preparation for export".
